

SOFTWARE LICENSE AGREEMENT

This Software License Agreement ("Agreement") is entered into by and between Backtwofront Technologies Ltd., a company registered under the laws of the United Kingdom ("Licensor"), and the individual or entity purchasing a license from darkmodeanything.com ("Licensee").

1. Definitions

- "Software" refers to the Darkmode Anything software developed and provided by Licensor, as purchased by Licensee from darkmodeanything.com.
- "License Key" refers to the unique code provided by Licensor to Licensee upon purchase, enabling the activation and use of the Software.

2. License Grant

This Agreement shall remain in effect until terminated. Licensor may terminate this Agreement immediately upon written notice if Licensee breaches any provision herein. Upon

termination, Licensee shall cease all use of the Software and destroy all copies in its possession.
